## SUMMARY

This compulsory subject will introduce students to the concepts, theories, tools and intervention strategies that characterise one of the most important professional fields of psychology: social and community intervention.

The psychology of social and community intervention is one of the branches of psychology that arises in response to the need to analyse and act on psychosocial problems, taking into account, in addition to the individual level, the interpersonal, situational and macro-social contexts in which they occur.

In this subject, students will find, in addition to the concepts, theoretical models and tools characteristic of the psychology of social and community intervention, examples of its application to various current social problems.

## TEACHING METHODOLOGY

The subject is taught using an active and participative methodology, making use of various teaching resources: the master class, audiovisual materials, seminars, individual and group work, student presentations, etc.

In the modules of the programme, in addition to the lectures, the active participation of the students in the development of the classes is encouraged by means of dynamics in the classroom and the presentation of exercises and questions that must be developed beforehand individually or in groups. Likewise, students will have to develop individual essays and group work, with the aim of developing the ability to articulate, synthesise and present the theoretical content of the subject, and to develop competences of a practical nature.

The use of mobile devices, tablets and laptops will be at the disposal of the teaching methodology proposed by each teacher.

Scheduled individual or group tutorials for the supervision of practical work, guidance and resolution of doubts.

## **EVALUATION**

The overall grade for the course will be obtained by adding the grades obtained in the written test (with a weight in the total grade of 80%) and the practical activities and/or assignments (with a weight in the total grade of 20%).

Assessment of learning will be based on:

- Assessment of theoretical and practical content by means of written tests, which may be developmental, short questions, case studies, multiple-choice, etc. and which are compulsory (80%).
- Oral or written presentation of reports, individual or group work, and/or analysis of cases (20%).

In the second call, the grades of the practical activities and/or work carried out during the course of the subject will be maintained. Those students who have not completed the activities and assignments at the first sitting may submit a selection of activities proposed by the lecturer at the second sitting which, when added to the exam, will allow them to achieve 100% of the grade.

The mention of Honours will follow the provisions of Article 17 of the Regulations of Evaluation and Grading of the UV. The procedure to be followed in the event of a tie in the grade will be established by the teaching staff at all times, notifying the students concerned, in the form of a written or oral test in which the contents of the subject will be assessed.

Minimum requirements

In order to pass the subject a passing grade must be obtained in the written test.
