SUMMARY

In the curriculum of the Master's Degree, this subject is integrated into itinerary II (Hispanic Literature and Theater) and III (Hispanic Training).

This subject has two complementary objectives. In the first place, it deals with the analysis of the theatrical shows and their evaluation, both from an academic and from a journalistic aspect. Its profile, consequently, is threefold: academic, research and professional, insofar as its purpose is to offer the student the basic elements for the understanding of the show and for its subsequent critical assessment, as well as the learning of the handling of reviews, critical comments and all bibliographic and networked instruments, which constitute basic sources of the history of scenic practices. Secondly, it is proposed to approach the analysis of dramatic texts, providing the student with the necessary tools for the understanding of dramaturgical work.

For the achievement of these purposes, we will work with theatrical texts previously indicated by the teacher, as well as with certain shows that may be on the poster throughout the course.

As detailed in the volume of work, theoretical classes are complemented by practical classes. To these face-to-face training activities is added participation in conferences and seminars organized by the Department of Spanish Philology.

DESCRIPTION OF CONTENTS

1. The concept of theatrical criticism and its historical perspective

The role of criticism. Criticism as a mediator between the creator and the audience. Criticism and the media. The social role of criticism. Techniques for the development of critical discourse.

2. The concept of theatre

The issue of its origins and genealogy. Scientific paradigms and models of theatrical analysis. Theater and text. Theater and literature. Theater and cinema. Translations, betrayals, concomitances.

3. Definition of concepts related to dramatic text

Author, playwright, adapter, dramaturgist, literary director, artistic director, stage director, version, adaptation. Status and lineage of the playwright in classical and contemporary theatre.

4. The components of drama

Preliminary information. Dialogues and stage directions. Plot and action. Conflict and characters. Time and space. Structures: acts, scenes, tableaux. Resolutions. Languages and metrics. Theatrical perspective.

5. Analysis and dramaturgical work

Practical development in class of a complete dramaturgical analysis project based on a specific work.

To identify the major trends in literary and theatrical criticism, contrasted with significant Spanish and Latin American theatrical texts, considering transversal, multidisciplinary, and ideological approaches.

To integrate knowledge and formulate independent judgments on critical theories and Hispanic theatrical works that consider the complex relationships between art and society.

To apply the acquired knowledge about techniques and procedures of theatrical works in new or little-known environments.

To debate and communicate the conclusions reached to specialized or non-specialized audiences in a clear and precise manner.

To produce individual or team projects in criticism, editing, and creation of Hispanic theatrical corpora.

TEACHING METHODOLOGY
